Promoter

Entry

2. Entry is free and open to all Australian residents, aged 18 years or older who purchase a WAECO CoolFreeze VER.B fridge/freezer (CF-35/40/50/50DZ/60/80/110) and fill out the online application form, available at www.dometic-waeco.com.au.
3. At the time of purchase of the WAECO fridge/freezer, entrants will receive a matching insulated protective cover at no cost, valued up to \$199 (based on the largest model CB-CF110). ACT residents are able to claim up to \$10,000.00 of the insulated protective cover giveaway.
4. Agents, retailers, suppliers associated with the Promoter and directors, officers, employees of the Promoter and their immediate families cannot enter.

 - (c) 3x monthly secondary prizes consist of 3x 'cash backs' of the purchase price of the relevant WAECO CoolFreeze VER.B fridge/freezers purchased by the winner. RRP

valued up to: \$1649 (based on promotional price of largest model CF-110). Winning entry will receive a cheque in the mail.
